Jan 16th-22nd (8hrs) \$240.00 Frog Pond lift station backed up to 2ft from top of station-no alarm and high level float was not hung up-power fluctuation was requiring a reset but dialer was indicting there was still power so I received no calls. By the recorded readings pump power was off for over two days but flow was still getting through because it was siphoning out downstream and because the flow from Pensaukee is at record lows it didn't overflow the station and I received no calls of backed up basements so backflow preventers must have been working. Returned daily to check levels until extreme cold weather broke and then replaced bad alarm float myself this time rather than calling electrician because they were marked better and it isn't just two wires to two wires but two wires from the float to 3 wires in the box and without them being marked I would never be able to replace them myself

Jan 24th(4hrs) \$120.00 4583 Oakland In-alarm-backed up-pump jammed with rope and glove-showed homeowner which has young children pulled pump and removed and checked pit for more (none found), put in degreaser and cleaned and fixed broken vent pipe
